# A BILL

To amend title 38, United States Code, to provide for the retroactive payment of benefits for veterans with covered mental health conditions based on military sexual trauma, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Moral Injury Recogni-  
5 tion and Restitution Act”.

1 **SEC. 2. DEPARTMENT OF VETERANS AFFAIRS RETRO-**  
2 **ACTIVE BENEFITS PAYMENTS FOR VETERANS**  
3 **WITH COVERED HEALTH CONDITIONS BASED**  
4 **ON MILITARY SEXUAL TRAUMA.**

5 (a) IN GENERAL.—Subchapter II of chapter 51 of  
6 title 38, United States Code, is amended by adding at the  
7 end the following new section:

8 **“§ 5114. Claims involving military sexual trauma: ret-**  
9 **roactive benefits payments**

10 “(a) IN GENERAL.—If the Secretary approves a  
11 claim for compensation for a covered health condition  
12 based on military sexual trauma experienced by a veteran  
13 during active military, naval, or air service, notwith-  
14 standing sections 5110 and 5111 of this title—

15 “(1) the effective date of the award of the claim  
16 shall be the date of the day after the date on which  
17 the veteran is discharged from such service; and

18 “(2) payment of monetary benefits based on  
19 such award shall be made beginning on such date  
20 and shall be payable retroactively.

21 “(b) DEFINITIONS.—In this section:

22 “(1) The term ‘military sexual trauma’ has the  
23 meaning given such term in section 1166(c)(2) of  
24 this title.

25 “(2) The term ‘covered health condition’  
26 means—

1           “(A) a covered mental health condition, as  
2           such term is defined in section 1166(c)(1) of  
3           this title; or

4           “(B) any physical injury or disease result-  
5           ing in disability that was incurred as a result  
6           of, or aggravated by, military sexual trauma.”.

7           (b) CLERICAL AMENDMENTS.—The table of sections  
8           at the beginning of chapter 51 of such title is amended  
9           by inserting after the item relating to section 5113 the  
10          following new item:

          “5114. Claims involving military sexual trauma: retroactive benefits payments.”.
